Substantial Amendment To The 2019-2020 Annual Action Plan & 2015-2019 Consolidated Plan

- Special allocation of CDBG-CV3 \$588,651 from the CARES Act
- Requires an amendment to the AAP & ConPlan
- Must prevent, prepare for, and respond to COVID-19.
- The amendment outlines activities consistent with HUD guidance
- The amendment proposes to fund a project that will result in the provision of homeless services:
 - Public Facilities Grant - Homeless Day Center
 - Onsite support services and resources (health & social services)
 - Restrooms, showers and laundry facilities
 - Telephones, mailbox/mailing address
 - Computer and Internet access
 - Educational opportunities/continuing education
 - Potential permanent housing in future phases
